The brief facts of the case as per the Complaint and other records received along with it are as follows:

#### Request for information U/s 6(1) of RTI Act, 2005 and its response:

The Complainant filed an Application dated 07.03.2024 U/s. 6(1) of the RTI Act, 2005
before the PIO by requesting to furnish the following information :

1)PMMSY స్క్రీమ్ క్షింద తమ జిల్లా సందర్శి గల రిజర్వాయర్లు, మైనర్ ఇరిగేషస్ చెరువుల సందు 2020,2021,2022,2023 వ సంవత్సరములలో చేపలు విత్తనాలను నిల్వచేసిందుకు ఉన్న తాదికారులు ఇచ్చిన ఆదేశాలు యొక్క ప్రతులు నకళ్ళను సంవత్సరాల చారిగా ఇవ్వగలరు.

2)PMMSY స్కేమ్ నండు స్టేట్ పర్చేజ్ కమిటీ/డెల్లా పర్చేజ్ కమిటీ చే ఆమోదించ బడియున్న ఒక్కొ చేపెపిల్లకు విర్ణయించిన ధర వివరాలను తెలియజేస్తూ మరియు సదరు చేపలు విత్తనాలను సరఫరా చేయుటకు ఉన్నిరాధికారులు మరియు తమరు ఇచ్చిన ఉత్తర్వుల యొక్క ప్రతుల సకళ్ళను ,మరియు చేపల విత్తనాలు కొనుగోలు చేసిన భిల్లుల యొక్క ప్రతుల సకళ్ళను 2020 వ సంవత్సరం నుండి 2023 వ సంవత్సరం వరకు ఇవ్వగలరు.

3) ప్రభుత్వ మరియు ఉన్నా కాదికారులు ఇచ్చిన ఆదేకాలు ప్రకారం సీద్ స్టాకింగ్ కమిటి సమాక్షమున తమ జిల్లా సండలి గల రిజర్వాయల్లు, మైనర్ ఇరిగేసన్ చెరువుల సందు 2020,2021,2022,2023 సంవత్సరములలో పదిలిఉన్న చేప పిల్లల వివరములు తెలియజేస్తూ,తెలుపు సీద్ స్టాకింగ్ కమిటి సర్టిఫికెట్ ,వారీ సెంటర్లను, ట్రాస్స్ పోర్టు నే బిల్లులు, వాటికి సంబందించిన ఫొటోలు అలాగే సీద్ స్టాకింగ్ కి సంబందించి కమిటి వారిచే సంతకములు చేసి ఉన్న పత్రములకు సంబందించిన ప్రతుల నకళ్ళు మొత్తం ఇవ్వగలరు.

4) గౌరవ సుప్రేంకోర్టు వారు ఇచ్చిన ఆదేశాలను అనుసరించి సమాచారహక్కువట్టం-2005 లోని సె.ఓస్ 4(1)A అనుసరించి ఏఏ రికార్డులను online చేసి ఉన్నారో సదరు రికార్డులు వివరాను తెలియజేయగలరు.

2. The PIO didn't respond to the 6(1) application.

#### Complaint U/s 18(1) of RTI Act, 2005:

3. As no information has been furnished by the PIO, the Complainant filed this present Complaint dated 20.05.2024 (Received on 20.05.2024) U/s. 18(1) of the RTI Act, 2005 before this Commission.

#### Notice Issued:

4. After examining the material papers available on record, the Complaint was taken on file, accordingly issued notices on **10.09.2024** and were sent to the both Complainant as well as Respondent.

#### Hearing:

- 5. The case is called for hearing on 17.10.2024.
- 6. The Complainant is present in person before this Commission. He stated that the information requested in his Section 6(1) application has not been provided to him to date. He requested that this Commission take action against the PIO under Sections 20(1) and 20(2) of the RTI Act, 2005, for failing to respond to his Section 6(1) application within the stipulated time.
- 7. The PIO & District Fisheries Officer is present in person before this Commission and has submitted an affidavit dated 16.10.2024. In this affidavit, he stated that the PIO furnished the requested information on 16.10.2024, by sending a letter to the Complainant. The PIO also indicated plans to hand over all enclosures to the Complainant during this hearing.
- 8. The PIO further explained that the Complainant requested substantial information, and due to the formation of a new district, a lack of staff, and work schedules assigned by his superiors, he was unable to provide the information within the stipulated time. He also submitted another letter dated 17.10.2024, detailing the reasons for the delay and requested this Commission to condone the delay in providing the information.
- 9. The PIO stated that, due to his failure to respond within the stipulated time to the Section 6(1) application, he is willing to provide the information free of charge. He also shown a bundle of documents containing the requested information to this Commission.
- 10. The PIO handed over the information to the Complainant in front of this Commission; however, the Complainant declined to accept it. He stated that the information is no longer necessary and requested this Commission to take action against the PIO under Sections 20(1) and 20(2) of the RTI Act, 2005, for failing to respond to his Section 6(1) application within the stipulated time.

#### **Decision:**

Upon perusal of the case file and after considering the arguments of both parties, this Commission notes that the PIO provided a set of documents to the Complainant free of charge due to the delay in furnishing information. However, the Complainant rejected this information because of the delay.

While the PIO has offered reasons for the six-month delay, this Commission finds it unacceptable. Therefore, this Commission opines that as per Section 19(8)(b) of RTI Act, 2005, the PIO is obligated to compensate the Complainant for any loss or detriment suffered due to the failure to provide the information within the stipulated time.

Therefore, the PIO is directed to pay an amount of Rs.2000/- (Rupees Two Thousand Only) to the Complainant as compensation U/s. 19(8)(b) of the RTI Act, 2005. This compensation is intended to cover the loss incurred by the Complainant due to the non-furnishing of information within the stipulated time. The payment should be made by cash or money order within one week from the date of receipt of this order.

The PIO is also directed to must submit compliance report to this Commission through Registered Post and through Email to <a href="mailto:sic2-apic@ap.gov.in">sic2-apic@ap.gov.in</a>, within 2 weeks from the date of receipt of this order.

The Complainant is advised to collect the information requested in the 6(1) application from the PIO, if necessary, within one week from the date of receipt of this order.

Accordingly, the complaint is disposed of.
